Professor of Community and Family Medicine
Duke University

Dr. Michener is Professor and past Chair of Community & Family Medicine at Duke. He has served as Director of the Duke Center for Community Research; co-chair of the Community Engagement Steering Committee for the Clinical and Translational Science Awards of the NIH; and President of the Association for Prevention, Teaching and Research. He has also been a member of the National Academies Institute of Medicine Committee on Integrating Primary Care and Public Health; the Board of Directors of the Association of Academic Medical Colleges; the NIH Council for Complementary and Alternative Medicine; and the National Academic Affiliations Advisory Council for the Department of Veterans Affairs. He now leads the “Practical Playbook”, with the support of the deBeaumont Foundation, linking health care, public health and communities.
