

## **Current Caseload**

- 2,932 open cases as of July 31, 2020
- 84 Petitions were filed in July 2020 vs 119 Petitions filed in July 2019
- Closed cases in July 2020 were on par with closed cases in July 2019.
- Calendar year to date OSM has observed a decrease of approximately 13% in Petition filings.

#### Pre-Assignment Review - "PAR"

- Started in September 2019.
- All new petitions are assigned to the Chief Special Master.
- A review of the case is conducted to ensure the record is substantially complete as required by Section 11 (c) of the Vaccine Act.
- After review if the record is determined to be substantially complete an Activation and Reassignment Order is issued.
- If the record is not substantially complete follow-up scheduling orders are issued until substantial completeness is achieved.
- The filing of certified records to expedite petition processing is required as of January 1, 2020.
- A PAR Questionnaire Form (which will assist in determining completeness of the record) is also required as of January 1, 2020.

## **Special Processing Unit - "SPU"**

Started in July 2014.


- Includes:
  - Table Cases
  - Other cases likely to settle
  - Cases that must be dismissed

### SPU PROCESS

- Cases meeting SPU criteria assigned to the Chief Special Master's docket after PAR Review
- Other cases assigned randomly
- Chief Special Master supervision, fact finding and decision making with staff attorney case management

#### Over Half of All Vaccine Cases Have Been Assigned to the SPU

- Since SPU began on July 1, 2014, 5,868 Vaccine Petitions have been filed and assigned.
- Of those 5,868 petitions, 3,422, or 58%, were assigned to SPU.
