To expand access in testing, vaccination, therapeutic treatment and ensure equity in COVID-19 response in rural communities, the Health Resources and Services Administration (HRSA) is working with Rural Health Clinics (RHCs) across the nation. This infographic provides information on the five RHC COVID-19 Programs and helps RHCs identify eligible activities within each program.



Testing and Mitigation (RHCCTM)

Maintain and expand access to COVID-19 testing and mitigation activities.



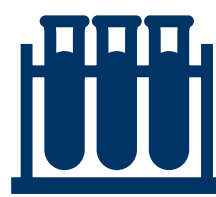
Vaccine Confidence (RHCVC)

Improve vaccine confidence.



Vaccine Distribution (RHCVD)

Deliver COVID-19 vaccines directly to RHCs to increase the availability of COVID-19 vaccines.



Testing Supply (RHCCTS)

Provide free COVID-19 testing supplies to RHCs.



Therapeutics (RHCTH)

Provide free COVID-19 antivirals to RHCs.
