What is Conflict of Interest?

- **Conflict of Interest Defined (45 CFR § 75.112)**
 - A significant financial interest that could directly compromise or bias professional judgment and objectivity related to the management of federal financial assistance.
 - Broadly defined, a potential conflict of interest includes external connections that may or may not appear to improperly **bias** an award recipient's judgment in performing his or her job responsibilities related to their federal award.


Why Focus on Conflict of Interest?

- **Good business practice**
- **Helps preserve integrity**
- **Improves your organization's internal controls**
- **HRSA award recipients are REQUIRED to have a written conflict of interest policy**

Testing for a Conflict of Interest

- **Reasonable person test**

- If a reasonable, disinterested person would conclude that an individual might emphasize personal interests over other interests for which he/she has responsibility, there is, at the very least, the appearance of a conflict of interest.



Why *Potential* Conflict of Interest?

- **Because a lot depends on the circumstances.**
 - For example, if steps are taken to remove an employee with a potential conflict of interest from being involved in a project, that may be a solution.

Examples

- **Accepting personal gratuities.**
- **Using or disclosing confidential information.**
- **Maintaining roles that conflict.**
- **One person overseeing all aspects of subcontracting or subawards.**
- **Competing financial interests.**
- **Conflicting employment outside the organization.**

HRSA's Federal Financial Assistance Conflict of Interest Policy

HHS requires that HRSA establish conflict of interest policies for federal awards that:

1. Address conditions under which **outside** activities, relationships, or financial interests are **proper** or **improper**;
2. Provide for advance **notification** of outside activities, relationships, or financial interests, and a process of **review** as appropriate; and
3. Outline **how** financial conflicts of interest may be **addressed**.

HRSA's Federal Financial Assistance Conflict of Interest Policy main points

- **Uniform Guidance Requirement (45 CFR §75.112)**

- **Disclosure Requirements to HRSA**

Conflict of Interest - Exceptions

- **Program statutes and regulations**
- **Does not apply to scientific conflicts of interest for research projects**
- **However this still applies when a pass-through entity gives a subaward for scientific collaboration**

What to do in Cases of a Conflict of Interest?

- **Follow your organization's conflict of interest policy.**
- **Do you think you have a conflict?**
- **Report it!**
- **Disclosure requirements.**
- **Failure to make required disclosures may result in additional conditions and could result in suspension or debarment.**

What will HRSA do?

- **Term and Condition in Notice of Awards (NoA)**
- **Review**
- **Respond**

Take Away

- Conflicts of interest are more frequent than we think. Be alert to the **risk**.
- A **perceived** conflict is as potentially damaging as a real conflict.
- Err on the side of caution. It's better to **over-disclose** than under-disclose.

Legislative Mandates in Grants Management for FY 2019

Department of Defense and Labor, Health and Human Services, and Education Appropriations Act for 2019, signed into law on September 28, 2018:

- Provides funding to HRSA for the fiscal year ending September 30, 2019.
- Includes statutory provisions that limit the use of funds on HRSA grants and cooperative agreements for FY 2019.

Legislative Mandates in Grants Management for FY 2019 (1-4)

Division B, Title II:

- **(1) Salary Limitation (Section 202)**
- **(2) Gun Control (Section 210)**

Division B, Title V:

- **(3) Anti-Lobbying (Section 503)**
- **(4) Acknowledgment of Federal Funding (Section 505)**

Legislative Mandates in Grants Management for FY 2019 (5-8)

Division B, Title V (cont'd):

- **(5) Restriction on Abortions (Section 506)**
- **(6) Exceptions to Restriction on Abortions (Section 507)**
- **(7) Ban on Funding Human Embryo Research (Section 508)**
- **(8) Limitation on Use of Funds for Promotion of Legalization of Controlled Substances (Section 509)**

Legislative Mandates in Grants Management for FY 2019 (9-12)

Division B, Title V (cont'd):

Division E, Title VII:

OMB Memo M-18-18 (Thresholds For Financial Assistance)

OMB Memo M-18-18: Implementing Statutory Changes to the Micro-Purchase and the Simplified Acquisition Thresholds for Financial Assistance.

- **On June 20, 2018, the OMB Memo raised:**
 - The threshold for micro-purchases under federal financial assistance awards from \$3,500 to \$10,000 and
 - The threshold for simplified acquisitions from \$150,000 to \$250,000. See definitions at 45 CFR § 75.2.
- **Institutions of Higher Education may request a higher micro-purchase threshold (above \$10,000) if you receive approval from your cognizant federal agency for indirect costs, with certain conditions**

OMB Memo M-18-18 (Thresholds For Financial Assistance) Cont.

What should you do?

1. Review the OMB Memo for awareness
2. Review External Policy Bulletin 2019-01E for awareness.
3. Document your implementation of the increased thresholds in your systems of internal control by updating your policies and procedures
4. Contact your Grants Management Specialist (with a CC to your Project Officer) with any other questions about the threshold increases
5. But organizations are not required to increase their acquisition threshold policies as a result of the OMB memo.
