

Notice Regarding Refunds to 340B Covered Entities

Alcon Laboratories, Inc. ("Alcon") has recalculated 340B Ceiling Prices for the products and corresponding national drug codes ("NDCs") referenced below for the sales period of January 1, 2019 through June 30, 2024. As a result of the recalculated 340B Ceiling Prices, Alcon has determined a refund may be owed to 340B Covered Entities that purchased any of the below products during the PHS sales period of January 1, 2019 through June 30, 2024 (1Q2019 – 2Q2024). Alcon will not seek repayment where Covered Entities paid below the recalculated 340B ceiling prices for the specified time periods, and such amounts will not reduce the total refund owed.

The table below identifies the NDCs, products, and sales periods that are subject to a refund. The recalculated Ceiling Prices are the result of revised pricing data submitted to the Centers for Medicare & Medicaid Services.

Alcon established an aggregated refund threshold of \$10 applicable to all products and PHS sales periods listed above. Covered Entities that are entitled to an aggregated refund of \$10 or greater will be contacted directly by, or on behalf of, Alcon with information on how the refund will be processed.

Covered Entities that are entitled to an aggregated refund across applicable NDCs of less than \$10 will not be contacted directly by, or on behalf of, Alcon. Instead, Alcon is offering a refund to these 340B Covered Entities through this Notice.

If a 340B Covered Entity does not receive a communication from, or on behalf of, Alcon and that 340B Covered Entity believes it is entitled to a refund on the applicable NDCs, then the 340B Covered Entity should contact Alcon at PHS.340B@alcon.com to request a refund. Please include "2025 340B Refund" and the applicable 340B IDs in the subject line. The body of the email shall include NDCs and Quantities purchased, Wholesaler, Wholesaler Invoice Number, and Wholesaler Invoice Date for all affected products.

Alcon has asked the Health Resources and Services Administration (HRSA) to post this Notice on HRSA's public website to ensure transparency to all 340B Covered Entities.
