



07/21/2025**Notice Regarding Offer of Refunds to 340B Covered Entities for Purchases of Eisai Products**

Eisai Inc. (“Eisai” or the “Company”) has recalculated the 340B Ceiling Prices for the NDCs listed below for 3Q2022:

As a result of the recalculated 340B Ceiling Prices, Eisai has determined that a refund is owed to 340B Covered Entities that purchased these products at the 340B Ceiling Price during 3Q2022.

Accordingly, Eisai will proactively issue refunds via Apexus, LLC (“Apexus”), the 340B Prime Vendor, to 340B Covered Entities that purchased these products during the quarters identified above and are owed a refund of more than \$40 dollars in the aggregate for the impacted quarters. Apexus will work with Eisai to validate wholesaler pharmacy account information for each covered entity. Once validated, Apexus will work with the wholesalers to facilitate the processing of credit for the differences between the amounts that the covered entity was charged and the 340B ceiling price during the specified periods. If an active wholesaler account cannot be identified within two weeks after the initial communication, then Apexus will work to issue an ACH or check to those entities.

Covered entities that believe they are owed a refund of less than \$40 dollars in the aggregate may request a refund by contacting Eisai at robert_sedlacek@eisai.com for assistance. Please include “340B Reimbursement” and your covered entity’s 340B ID in the subject line.

To enable processing of such refund requests, Covered Entities (CE’s) must provide the following information: Covered Entity ID, NDC Number, Quantity, Original Purchase Invoice

Eisai has asked the Health Resources and Services Administration (“HRSA”) to post this Notice on the HRSA’s public website to ensure transparency to all 340B Covered Entities regarding the 340B Ceiling Price recalculations for the products identified above and Eisai’s refund process.
