

## Notice of Changes to 340B Prices

3/2/2026

Pursuant to 42 C.F.R. § 447.510(b), Eli Lilly and Company (Lilly) has submitted routine updated 4Q2022 Average Manufacturer Prices and Best Prices for certain of its covered outpatient drugs to the Centers for Medicare & Medicare Services (CMS) to account for lagged transactional data. These restated Medicaid prices result in both upward and downward adjustments to 2Q2023 340B Ceiling Prices.
