A Message Regarding Potential PHS Refund

Recently, Granules Pharmaceuticals completed a minor restatement of government pricing values. These minor restatements impacted the Public Health Service pricing on certain drugs that were purchased between 10/1/2021 and 5/31/2023. Granules Pharmaceuticals has identified all Covered Entities that may be owed a refund for purchases during this timeframe and is in the process of directly contacting any Covered Entity owed a refund greater than \$50.00 by U.S. mail.

Granules Pharmaceuticals is also committed to issuing a refund to any Covered Entity that was overcharged on a PHS purchase made between 10/1/2021 and 5/31/2023 that was not contacted directly via U.S. mail – this includes Covered Entities owed a refund of less than \$50.00.

Covered Entities that wish to inquire can do so by emailing rebates@prescriptionanalytics.com March 31, 2024. The Covered Entity will be asked to provide proper documentation of an overcharge during the relevant time period. However, Granules is committed to working with eligible covered entities to determine if there was over payment and issue the appropriate refund owed, if any.

Refund checks will be issued to the facility and matching Federal Tax ID number.
