**NOTICE OF NDC CHANGE**  
Lioresal® Intrathecal (baclofen injection)  
CUSTOMERS SHOULD UPDATE THEIR SYSTEMS  
EFFECTIVE MARCH 2023

Amneal Pharmaceuticals LLC (“Amneal”) has asked the Office of Pharmacy Affairs (“OPA”) to post this Notice of NDC Change on OPA’s public website to notify Amneal’s customers who are 340B covered entities that the national drug code (“NDC”) numbers for Lioresal® Intrathecal Baclofen are being transitioned to new NDCs effective as follows:

The table above sets forth the old and new NDCs for Lioresal. Because the new Lioresal NDCs are for the same product (drug, dose, or formulation) and have the same 340B price as the corresponding old NDC, Amneal will allow eligible 340B covered entities that use a 340B compliant inventory replenishment model to count accumulations of the old NDCs toward replenishment of equal quantities of the corresponding new NDCs. ***Amneal wishes to emphasize that 340B pricing for the new NDCs will remain the same as for the old NDCs.***

Amneal will sell the remaining inventory of each old NDC until it is exhausted, after which point, Amneal will begin distributing the corresponding new NDC. No orders will be processed for the new NDC until the old NDC inventory has been depleted. As Amneal depletes inventory on the remaining SKU’s, we will notify our customers accordingly. Chargebacks and returns will continue to be processed for the old NDCs.
