#### Introduction

The Normothermic Regional Perfusion (NRP) Workgroup (the Workgroup) met via Microsoft Teams teleconference to discuss the following agenda items:

- 1. Welcome and November 10th Meeting Recap
- 2. Review Draft Safety Alert for NRP

The following is a summary of the Workgroup's discussions.

#### 1. Welcome and November 10th Meeting Recap

#### Summary of discussion:

The Workgroup reviewed the 11/6 DCD Safety Alert and discussed information to include in a future NRP Safety Alert. HRSA provided an update on collecting and sharing deidentified NRP policies and practices and adverse events with the Workgroup.

#### Next steps:

- NRP Safety Alert will replace previously drafted communication on NRP
- HRSA to build a collection tool for OPTN Members to submit policies/practices, which can inform the policy development process
- After NRP Safety Alert is complete, the Workgroup can consider putting specific NRP safeguards in OPTN policy

#### 2. Finalize Draft of Initial NRP Communication

#### Summary of discussion:

The Workgroup discussed the need for clear, actionable safety guidance, especially regarding the prevention of blood flow to the brain during NRP procedures. The Workgroup debated the best methods for ensuring complete occlusion of the aorta and head vessels, including clamping, transection, and the use of balloons. There was consensus that transection is the only way to guarantee no blood flow to the brain, but this introduces challenges, especially in pediatric cases and patients with high BMI. The discussion highlighted the importance of erring on the side of safety for both donors and public perception. There was acknowledgment that some parties may view the proposed measures as either too cautious or not cautious enough.

#### Next steps:

Get broader input from additional voices from the OPTN Ethics and OPO committees
