

## **OPTN Pediatric Transplantation Committee**

### **Meeting Summary**

### **Introduction**

The Pediatric Transplantation Committee (the Committee) met via WebEx teleconference on 5/22/2025 to discuss the following agenda items:

The following is a summary of the Committee's discussions.

#### **1. Announcement: Revisions to Human Immunodeficiency Virus (HIV) Policies to Align with Federal Regulatory Updates**

The proposal *Revisions to HIV Policies to Align with Federal Regulatory Updates* was available for a special public comment period, March 21 to April 17, 2025.

##### Summary of discussion:

No decisions were made.

The Chair gave a high-level overview of the proposal and informed the Committee that it would be considered for approval by the OPTN Board of Directors during their June 9-10, 2025 meeting. The Chair noted that HIV transplants are relatively infrequent in pediatrics. There were no questions or comments from committee members.

#### **2. Announcement: Board Elections Reminder**

The Transitional Nominating Committee (TNC) recommended a slate of candidates to the Secretary of the U.S. Department of Health and Human Services, who approved the nominees for the OPTN Board of Directors national election. The ballot for the OPTN Board of Directors national election will be open from 11 a.m. ET on May 23, 2025, to 11:59 p.m. ET on June 2, 2025.

##### Summary of discussion

The Chair highlighted the pediatric representation on the national ballot. There was brief discussion about pediatric representation on the OPTN Board of Directors.

### **3. Recap: 4/3/2025 Lost to Follow-up and Transfers Workgroup meeting**

The OPTN Lost to Follow-up (LTFU) and Transfers Workgroup (the Workgroup) first met on April 3, 2025<sup>1</sup>. As a result of that meeting, a data request was submitted to inform the LTFU and Transfers project.

#### Summary of discussion

There was a recap of the April Workgroup meeting, and an overview of the data request was given. There were no questions or comments from committee members.

### **4. Open Discussion**

In their extra time on the call, the Committee received a brief update on some of the OPTN work related to allocation out of sequence; the update was provided by a committee member acting as the Committee's representative.

#### Summary of discussion

A committee member discussed their recent participation in an OPTN meeting to develop a definition for allocation out of sequence (AOOS), as part of the OPTN response to a HRSA directive letter.

### **5. Open Forum**

A committee member requested to speak during the open forum portion of the meeting. More information on the public access plan can be found on the OPTN website.<sup>2</sup>

#### Summary of discussion

A committee member shared their concerns about state legislation surrounding vaccines mandates and vaccine status disclosure, and the potential pediatric transplant impacts. Members discussed possible avenues for advocacy outside of the OPTN.
